# Routes of Exposure:

If in Eyes Rinse cautiously with water for 15 minutes. Remove contact lenses, if

present and easy to do. Continue rinsing. If eye irritation persists call

doctor/physician.

If on Skin 
If skin or hair contact occurs, remove contaminated clothing and flush skin

and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. For gross contamination, immediately drench with water and remove clothing. Continue to flush skin and hair with plenty of water (and soap if material is insoluble). For skin burns, cover with a clean, dry dressing until medical help is available. #### Section 6. Accidental Release Measures

#### **SMALL SPILLS**
