## 4. FIRST AID MEASURES

# **Acute toxicity**

Very low toxicity if swallowed. Harmful effects not anticipated from swallowing small amounts. As product: LD50, Rat, female > 5,000 mg/kg

#### Acute dermal toxicity

Prolonged skin contact is unlikely to result in absorption of harmful amounts.

#### Acute inhalation toxicity

No adverse effects are anticipated from single exposure to vapour. Excessive exposure may cause irritation to upper respiratory tract (nose and throat).

For the active ingredient: Aminopyralid. In animals, effects have been reported on the following organs: gastrointestinal tract.

For the minor component(s): In humans, ingestion has resulted in no significant adverse effects. May cause abdominal discomfort or diarrhea.

## Carcinogenicity

For active ingredient: Aminopyralid. Did not cause cancer in laboratory animals For similar active ingredient(s). Picloram. Did not cause cancer in laboratory animals.

# Teratogenicity

For the active ingredient(s): Did not cause birth defects or any other fetal effects in laboratory animals.

## Reproductive toxicity

For similar active ingredient(s). Aminopyralid. Picloram. In animal studies, did not interfere with reproduction.

#### Mutagenicity

For similar active ingredient(s). Aminopyralid. *In vitro* genetic toxicity studies were negative. Animal genetic toxicity studies were negative.

The preponderance of data shows picloram to be non-mutagenic in 'in vitro' (test tube) tests and in animal test systems.
