Recommended use of the chemical and restrictions on use

Wetting agent to enhance deposition and retention of herbicide and pesticide sprays. Suitable for use in situations where low toxicity to aquatic organisms is required.

2. HAZARD IDENTIFICATION

5. FIRE-FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Emergency Procedures

Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. Slippery when wet. If possible contain the spill. As a water based product, if spilt on electrical equipment the product will cause short-circuits. Place inert absorbent material onto spillage. Collect the material and place into a suitable labelled container. Do not dilute material but contain.

Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid inhalation of vapours and mists, and skin or eye contact. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of mists or vapours in the work atmosphere. Maintain high standards of personal hygiene i.e. washing hands prior to eating, drinking, smoking or using toilet facilities.

Conditions for safe storage, including any incompatibilities

Protect from freezing. Store in a cool, dry, well-ventilated area, out of direct sunlight. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.

13. DISPOSAL CONSIDERATIONS

Disposal considerations

In this specific case the product is water-based/water-soluble and therefore can be sent through a Waste Water Treatment Plant and after treatment can be discharged into environment through the sewerage or drainage systems as authorized. The ventilation requirements as specified in the same section must also be followed, and the precautions given in Section 7 of this SDS regarding handling must also be followed. Do
