### Section 4: First Aid Measures

#### Symptoms of exposure:

If Swallowed	Can result in nausea, vomiting, diarrhoea and abdominal pain.
If in Eyes	Will cause eye irritation.
If on Skin	Contact with skin may result in moderate irritation.
If Inhaled	Inhalation of mist will result in respiratory irritation.

#### First aid actions:

If Swallowed	If exposed, concerned or if symptoms persist: Get medical attention/advice. If medical advice is needed, have product container or label at hand. Do not induce vomiting. Give plenty of water to drink. If vomiting occurs give further water. Seek medical advice.
If in Eyes	Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists, get medical advice/attention.
If on Skin	Remove contaminated clothing. Rinse skin/hair with plenty of water. If swelling, redness, blistering, or irritation occurs seek medical advice. Wash clothing before reuse.
If Inhaled	Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

#### Workplace facilities:

For volumes >500L – 2 fire extinguishers must be available. An eyewash and general hygiene facilities are also recommended.

### Section 5: Fire Fighting Measures
