SECTION 4: First Aid Measures

Skin contact: Wash with soap and water. Wash contaminated clothing before reuse.

SECTION 6: Accidental Release Measures

Wear appropriate protective equipment (see Section 8). Clear the area of all unprotected personnel. Prevent entry of chemical or used/damaged containers into sewers, drains, streams or waterways. If necessary, inform the police and the Regional Council. For the purposes of complying with Hazardous Substances (Disposal) Regulations (2001) this SDS must be made available within 10 minutes to any person using the product.

Small Spill: Use personal protective equipment. Do not allow to enter drains or waterways. Do not discharge into the subsoil/soil. Take up with absorbent material.

Large Spill: Wear protective clothing and equipment (see Section 8). Stop further release of spilled material. Take up with absorbent material and place in secure containers for disposal. Handling

Avoid contact with eyes and skin. Keep away from food, drink and animal feedstuffs. After work, remove protective clothing, and wash hands before eating, smoking, drinking or using the toilet. Clean up spilled material immediately, and wash clothes, equipment and work area after use.

Storage

Keep out of reach of children and animals. Store in tightly closed original containers in a cool, dry, well-ventilated area out of direct sunlight. Do not store with food, feedstuffs, fertilisers and seeds.
