4. FIRST AID MEASURES

7. HANDLING AND STORAGE

- Handling:** Avoid eye contact and skin contact. Avoid inhalation of vapour, mist or aerosols.
- Storage:** Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Keep container standing upright. Keep containers closed when not in use - check regularly for leaks.
